A ready-to-use bactericidal and fungicidal liquid (fungi) for disinfection surfaces and production lines in the food industry, including food-contact surfaces. Recommended for use in spa and wellness centers, hair and beauty salons, catering establishments. Tested to PN-EN 13697. The biocidal product authorisation No 5401/13. COMPOSITION:

<5% cationic surfactants, <5% alcohol

APPLICATION:

Product ready to use . On the previously cleansed surface, apply product with a sprayer, let stand for at least 60 seconds. After disinfecting surfaces being in contact with food must be rinsed with potable water.

THREAD:

Product is not a mixture of hazardous in accordance with applicable regulations. (Regulation of the European Parliament and Council Regulation (EC) No 1272/2008).

FIRST AID:

In case of the appearance of symptoms of inhalation poisoning (cough, feeling the airlessness, the giddiness) lead the aggrieved party to the fresh air, consult the doctor. In case of the contamination of clothes, remove it , wash the skin with the large amount of water (best current). In case of the appearance of skin changes or burns see the doctor. Wash polluted eyes with a lot of cool water (at least for 15 minutes) dividing the eyelid individually, consult a specialist. In case of the consumption not to trigger the vomiting. Pass the large amount of water to drinking. Not to give neutralizing agents. Immediately consult the doctor, if it is possible show the label.

DIRECT AND INDIRECT INCIDENTAL EFFECTS OF APPLYING:

In the case of long-term exposure to the product and no ventilation may cause drowsiness, dizziness, irritation of the upper respiratory tract. In contact with skin and eyes causes irritation. As a result, of consumption may cause irritation.

DEALING WITH WASTE OF THE PRODUCT:

The product is best to use in its entirety. Small amounts of unused product may be dissolved and flushed with large amounts of water. Large quantities of the product does not pour into drains but give a specialized company for recycling or returned to the manufacturer.

DEALING WITH THE PACKAGE AND PACKAGING WASTES AFTER PRODUCT:

Empty container rinse several times with water which use like a product. Empty container returned to the retailer or to a specialized company for recycling.

SELL -BY DATE

36 months from date of manufacture. Date of production / series and the expiration date stated on the packaging.

ADDITIONAL INFORMATION:

Contaminated packaging should be emptied. Empty container rinse with water several times, which use it as preparation. Empty packaging can be stored in containers for plastic packaging or transfer to special company to utilization. Observe the provisions of the Act of 13 June 2013.
